

## **Edmonton's Countryside Contest ERTG – Global Edmonton**

THE **Edmonton's Countryside** CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF **Alberta** OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

**1. ELIGIBILITY.** To be eligible for this Contest, an individual must:

(a) be a legal resident of the province of Alberta;

(b) be of the age of majority in his/her province or territory of residence or older at the time of entry. Any entrant under the age of majority must have a parent or legal guardian sign on their behalf all necessary documentation in respect of this Contest, including entry forms and releases];

Employees of Edmonton Regional Tourism Group; Counties of Sturgeon, Strathcona, Lamont, Parkland and Leduc, participating municipalities in the ERTG zone, and Operators/Businesses who are members of the ERTG (collectively the participants) and employees of Global Edmonton, Realtors Association, Travel Alberta (collectively, the "Sponsors"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

**2. CONTEST PERIOD.** The Contest begins at 6 AM /Mountain Standard Time ("MST")/on Friday, August 6<sup>th</sup>, 2010 and ends at noon (12:00 PM MST on Tuesday, August 10<sup>th</sup>, 2010.(the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

### **3. HOW TO ENTER.**

(a) There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.

(i) To enter online, complete and submit the entry form located at <http://www.globalertgcontest.com/> (the "Contest Website").

(d) Limit of one (1) entry per e-mail address during the Contest Period]. In the case of multiple entries, only the first eligible entry will be considered.

(e) 1 Bonus entry per email address will be given to new subscribers of the Edmonton's

Countryside monthly e-newsletter.

(f) All entries become the sole property of the Sponsors.

#### **4. PRIZE**

(a) There is one (1) winner for the contest period receiving an Edmonton`s Countryside gift basket with an approximate value of \$400.00 CDN

(b) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

(c) Winner will be contacted by email (and-or) phone and will have up to 48 hours to respond and claim their prize.

(a) On or about Tuesday, June 8, 2010 in Edmonton, Alberta. 1 entrant[s] will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail,] to comply with the Contest Rules and sign and return the Release when prize is picked up.
